General Requirements for Nursing and Personal Care

- a) The facility must provide the necessary care and services to attain or maintain the highest practicable physical, mental, and psychological well-being of the resident, in accordance with each resident's comprehensive assessment and plan of care. Adequate and properly supervised nursing care and personal care shall be provided to each resident to meet the total nursing and personal care needs of the resident. Restorative measures shall include at a minimum the following procedures:
- 5) All nursing personnel shall assist and encourage residents with ambulation and safe transfer activities as often as necessary in an effort to help them retain or maintain their highest practicable level of functioning.

Based on interview and record review the facility failed to transfer R4 from chair to bed without injury.

Examples include:

E1 stated that the facility's investigation found E3 transferred R4 improperly resulting in R4's fractures. E1 stated that R4's diagnosis of osteoporosis contributed to the problem.

Review of incident reports, hospital x-ray reports and nursing notes indicate R4 sustained Three fractures on the lower right leg. R4 is a 100 year old resident on hospice whose diagnoses include osteoporosis and osteoarthritis. On 7/22/07 at 6:30 PM, R4 was being transferred from her wheel chair to the bed. E3 lifted R4 from her wheelchair and quickly turned which resulted in R4's right leg twisting and the fractures occurring.

The facility's investigation concluded that E3 failed to utilize the proper body mechanics when transferring R4. During the transfer E3 did not bring R4 to a full standing position before starting a pivot turn toward the bed.
