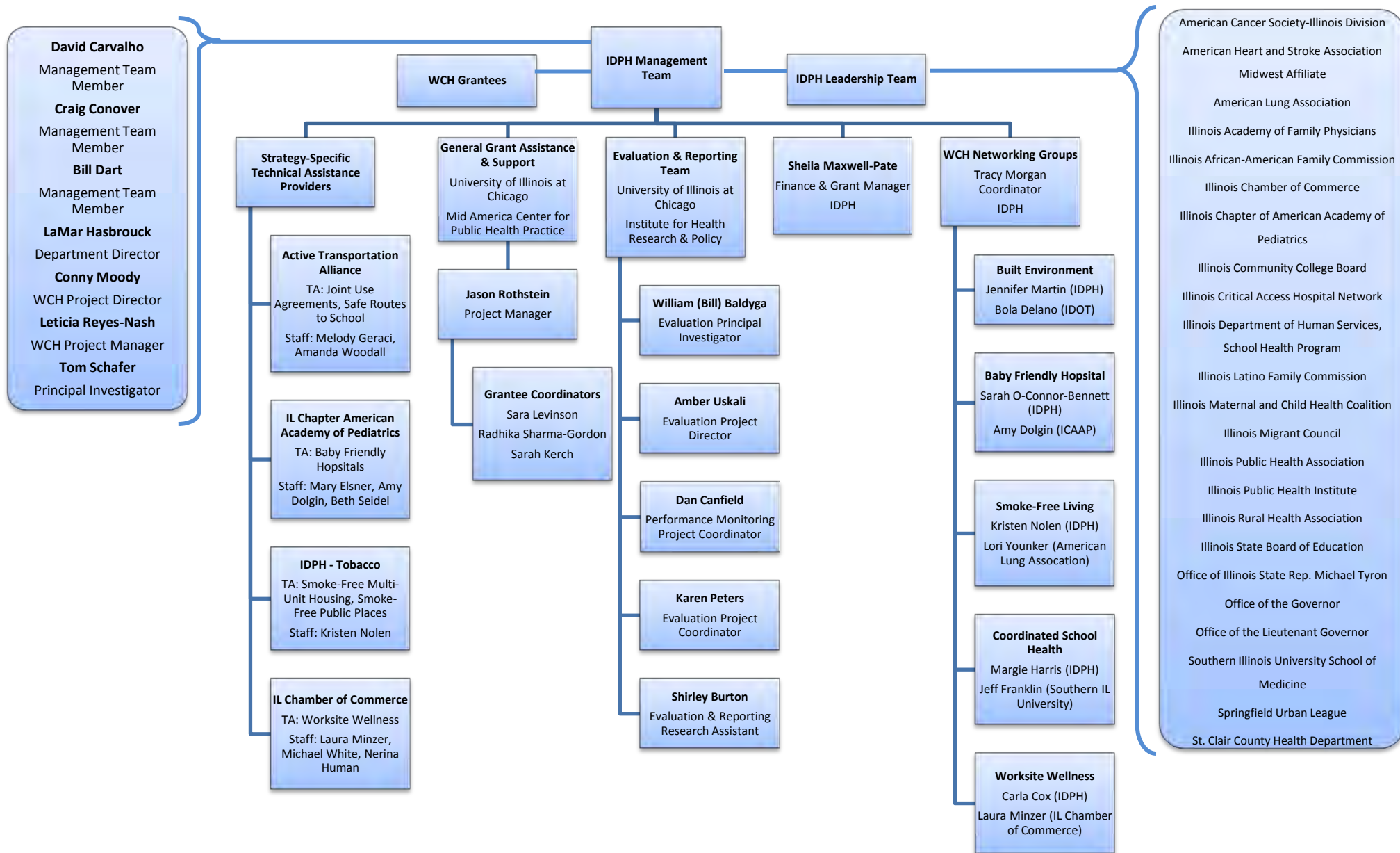


We Choose Health Project Organizational Chart
